

# **Operating Instructions** Perfluoroisobutylene (PFIB) Badge (Part Number: 382025)

#### Introduction

Perfluoroisobutylene (PFIB) is a highly toxic, colorless, odorless gas which is a respiratory hazard. PFIB irritates the respiratory tract. Inhalation exposure may cause severe symptoms of pulmonary edema. However, severe symptoms of pulmonary edema may be delayed for several hours before a rapid deterioration of health occurs. Excessive exposure may cause death.

PFIB is produced as a significant by-product in the manufacture of fluoropolymers, tetrafluoroethylene and hexafluoropropylene. It is also used as etching material for the semiconductor fabrication and synthesis of polymeric materials industry. Because of its high toxicity to humans, PFIB is designated as a Chemical Warfare Agent (CWA) and therefore is contained in Schedule 2 of the Chemical Weapons Convention (CWC).

## **Principle of Operation**

The SafeAir Perfluoroisobutylene (PFIB) badge is a monitoring system designed to indicate the presence of PFIB at concentrations below the permissible exposure limit. The SafeAir PFIB badge detects the presence of PFIB by forming a color change in the shape of a half triangle. This indication is produced by a colorforming reaction which occurs when PFIB reacts with a flat indicator layer.

# **Operating Instructions**

- Allow the badge to warm to room temperature prior to removing the badge 1. from its protective pouch. Dispose of pouch and humidity pack.
- 2. For personnel monitoring, attach the badge near the user's breathing zone (i.e. the collar) with the front side exposed to the surrounding atmosphere.
- 3. For area monitoring, attach the badge to a stand and mount in a centralized area with the front side exposed to the surrounding atmosphere.
- 4. The half triangle will appear on the front side of the badge when PFIB is present.
- 5. When using the SafeAir PFIB color comparator, read badge within 30 minutes of the end of the sampling period.

Warning: Do not disassemble badge. Keep out of reach of children, if ingested seek medical attention immediately.
